The Juvenile Crime Prevention Council (JCPC) has studied the risk factors and needs of Juvenile Court involved youth in this county and hereby publishes this Request for Proposals. The JCPC anticipates funds from the NC Dept. of Public Safety, Division of Juvenile Justice in the amount stated above to fund the program types specified below. Such programs will serve delinquent and at-risk youth for the state **fiscal year 2018-2019** beginning on, or after, **July 1, 2018**. The use of these funds in this county **requires a local match** in the amount specified above.

The JCPC will consider proposals for the following needed programs:

Home Based Family Counseling	Mentoring	Interpersonal Skill/Life Skills Classes
Parent/Family Skills Classes	Temporary Shelter Care	Tutoring/Academic Enhancement that
Restitution/Community Service	Counseling (Individual, Group, Family)	includes educational advocacy
Anger Management Classes	Cognitive Behavioral Groups	Mediation

Proposed program services should target the following risk factors for delinquency or repeat delinquency:

Adjudicated youth with: peer relationship issues or associate with delinquent youth, have moderate or serious school behavioral problems, have some substance use or abuse and are in need of further assessment or treatment, who have parents who have problems with providing adequate levels of supervision and youth who are twelve years old or younger at the time of their first referral to juvenile court.

Programs should address the following concerns as reported in the Needs Assessments for adjudicated youth:

Peer Domain: Adjudicated youth who sometimes associate with delinquent peers or lack pro-social peers.
Individual Domain: Adjudicated or at risk youth who need substance abuse assessment and/or treatment, need mental health assessments and/or treatment and have a history of victimization.
Family Domain: Adjudicated youth who have parents who have marginal parenting skills, reside in homes with domestic discord, are in need of parent/family supervision skills classes or family counseling.
School Domain: Adjudicated or at risk youth who have multiple unexcused absences, short term or long term suspensions or who have school disciplinary problems.

Applicants are being sought that are able to address items below:

1. Program services compatible with research that are shown to be effective with juvenile offenders.
2. Program services are outcome-based.
3. The program has an evaluation component.
4. Program services detect gang participation and divert individuals from gang participation.

Local public agencies, 501(c)(3) non-profit corporations and local housing authorities are invited to submit applications to provide services addressing the above elements.
